We have listed some important items that might be helpful during your stay.

SAFE & EASY CHECK IN PROCESS: On your arrival day, you will receive a text alerting you when your vacation rental is ready for you to check in. We ask that you proceed to our office at that time. We will have a check in package ready for you which will include keys/entry instructions, amenity passes, wifi instructions, driving directions from our office to your rental location and any other important information required for your stay. We ask that just one person for each reservation come to our front door. From the front door there will be visible viewing opportunity and when the check in station is not occupied by another person, we ask that you enter to receive your check in package (there will be directional signs to assist you). Our office/staff members will be following recommended guidelines in order to keep this process safe. All late check-ins must make prior arrangements with our office in order to pick up keys after office hours. A copy of your drivers' license must be on file before lock box can be accessed. A Seaside Vacations representative may reach out to you the day after check in to make sure you are settled in and everything is satisfactory. If you are arriving after office hours, please be sure to arrange for an 'after hours check-in procedure'

**HELPFUL INFORMATION:** If you have rented a condominium/townhouse/villa, please be aware that the on-site property management (HOA management companies) will be providing extra cleaning processes to all common areas including elevators, lobbies and amenities. An announcement was made the pools and common areas would be able to open as of May 18, 2020. This does NOT mean that every property will open all amenities. Seaside Vacations cannot guarantee the use of these amenities, it is possible that you will not have access to all building/property amenities. There is also the possibility that some pools will be open but guests will be expected to bring their own chairs as the 'building management' will not supply pool furniture. Seaside Vacations will not be providing any refunds as a result of any unavailable amenities.

The housekeeping staff at Seaside Vacations are following CDC guidelines and using EPA approved cleaning products to provide you with cleaning services using extra sanitizing and disinfecting processes. # **Terms and Conditions**

#### **Cancellation Policy:**

Your deposit, which constitutes approximately one half of your balance is for the rental unit and period listed on the front of this Confirmation/Lease. This deposit will be applied to the total rent. To receive a refund, cancellation must be received 60 Days prior to your arrival. A \$100.00 service and handling charge will apply. If cancellation is received less than 60 days from arrival you understand that the deposit will not be refunded unless the rental unit is re-rented at the same rate for the same period. You further understand that if the unit is re-rented, your deposit will be refunded less a \$100.00 service and handling charge and the travelers insurance premium if purchased.

# **Travel Insurance/Security Deposits:**

Seaside Vacations has contracted with Red Sky Travel Insurance in order to offer <u>Travel Protection Insurance</u> to our guests. Your Lease Agreement will include this optional coverage, which will cost only 6.95% of your total rental amount. The insurance coverage not only protects your vacation investment against hurricanes, but also covers other unanticipated circumstances which could cause cancellation/interruption of your trip. Please refer to the policy for exact coverage.

As part of your stay you may purchase a Security Deposit Protection plan designed to cover unintentional damages to the rental unit interior that occur during your stay. If purchased, the policy will pay a maximum benefit of \$1500. Any damages that exceed \$1500 will be charged to the credit card on file. If, during your stay at one of our Rental Properties, an Insured Person causes any damage to real or personal property of the unit as a result of inadvertent acts or omissions, the Insurer will reimburse the Insured for the cost of the repair or replacement of such property up to a maximum benefit of \$1500. Certain terms and conditions apply. Full details of the Security Deposit Protection coverage are contained in the Certificate of Insurance or Insurance Policy. The Security Deposit Protection plan can be purchased at \$55 per rental up to, and including at, the time of final payment. By submitting payment for this plan, you authorize and request Red Sky Travel Insurance and Insurance Services to pay directly Seaside Vacations any amount

payable under the terms and conditions of the Security Deposit Protection. If you do NOT purchase a Security Deposit Protection plan, the security deposit will be paid in full when making your final payment and returned via check or credit card within 4 weeks after your departure. Furthermore, Seaside Vacations reserves the right to a charge of \$100.00 per person security deposit. Such right is solely at the discretion of Seaside Vacations and shall be paid at the time of check-in.

# You will agree to the following regulations:

- 1. To clean up unit prior to departure. This includes emptying trash, placing dishes in dishwasher and starting and placing all dirty linens in bathtub. An additional cleaning fee is charged to all guests renting houses. This fee is included in your rental charges.
- 2. To take full financial responsibility for any damages, caused by any member of your party, accidental or not, to the premises and/or common areas and to pay for the repair of same to the satisfaction of the owner.
- 3. To return all keys, pool passes, etc. to Seaside Vacations office upon departure.
- Pets are **NOT** allowed under any circumstances and occupancy can be refused and/or terminated without any refunds.
   (designated pet-friendly properties excluded)
- 5. Seaside Vacations rents to families only. If a family is misrepresented or a house party is found occupying a rental unit, occupancy will be terminated without any refunds. <a href="Spring break/graduation groups & parties">Spring break/graduation groups & parties</a>, wedding receptions are NOT ALLOWED. You must be at least 25 years old to rent from any property.
- 6. The number in a rental party may not exceed the number of people the unit sleeps. This does not include children in cribs.
- 7. Seaside Vacations and/or the owner cannot be responsible for any items left in the unit. Fees apply for retrieving/shipping items.
- 8. **Furnishings may not be moved or relocated.** Charges can be incurred. Please leave property as you found it.
- 9. Not all units have landlines. Long Distance and/or information calls must be placed through the operator as collect or calling card calls.

  If not, a \$5.00 per call charge will be added to any toll charges.
- 10. The discharge of **Fireworks** is unlawful in all areas of North Myrtle Beach, including the beach. Besides civil penalties, occupancy of rental unit will be immediately terminated without any refund.
- 11. Towels, bathing suits and any other items shall not be hung from any balcony railings.
- 12. The feeding of birds from a balcony is prohibited.
- 13. The use of any BAR-B-Q grills is prohibited anywhere on the property, unless such area is provided by the complex you are renting.
- 14. Campers, trailers, motor homes, motorcycles are not allowed to be parked in parking lots.
- 15. CONDOMINIUM RENTAL PROPERTIES: Parking is limited to two (2) cars for 1, 2, and 3 bedroom rentals. SOME four bedroom rentals have three (3) parking spaces. If you have special parking needs, please check with our staff.
- 16. HOUSE RENTALS: Some house rentals have limited parking spaces (depending on the property size).
- 17. As these are privately owned units, furnishings and equipment are subject to change without notice.

- 18. There will be no refund of any kind due to mechanical failure of non-essential items such as air conditioner, TV, Internet, dishwasher, microwave, washer/dryer, or other luxury items. Seaside Vacations attempts to keep everything in your rental property in good working condition, but should any failure occur, we will make every effort to correct the issue promptly.
- 19. Seaside Vacations reserves the right to make changes, corrections and additions to literature and rates without previous notification.
- 20. All rules and regulations of the reserved rental property will be adhered to and followed.
- 21. As the owner of rental deposit funds, any interest benefits of these funds which accrue in an interest bearing account will be paid to Seaside Vacations.
- 22. All reservations will require a processing fee (amount depends on the property).
- 23. Your check-in location is at 501 Main Street, North Myrtle Beach. PLEASE NOTE the check-in process begins at 3:00PM. Upon completion of housekeeping services, your rental will be released to you SOMETIME between 3:00PM and 5:00PM.
